1. LAFAYETTE COLLEGE and/or its officers and employees as well as its representatives, agents, and companies are not responsible for inability to obtain any tickets or reservations requested by the student or for failure to make arrangements for transport, conveyance, or hotel or other accommodations which are not available at the time an order is placed on behalf of the student, but with the understanding that equal substitute arrangements will be provided in case of cancellations or modifications, and with the agreement that the student be notified of such changes as soon as it is reasonably practical to do so.

LAFAYETTE COLLEGE is not responsible for the welfare of participants during periods of independent travel or during any absences from the program.

2. LAFAYETTE COLLEGE and/or its officers and employees as well as its representatives, agents, and companies have the right to decline or accept or retain or dismiss any person as a member of the program at any time for cause. The student is responsible for appropriate behavior in line with the code conduct as described in the Student Handbook, as is the case with students in the course of the normal LAFAYETTE COLLEGE academic year.
